RESOLUTION TO AMEND 2021 BUDGET**

WHEREAS, the Board of Directors of Cherry Creek South Metropolitan District No. 5 (the “**District**”) certifies that at a special meeting of the Board of Directors of the District held November 9, 2021, a public hearing was held regarding the 2021 amended budget, and, subsequent thereto, the following Resolution was adopted by affirmative vote of a majority of the Board of Directors:

WHEREAS, the Board of Directors of the District adopted a budget and appropriated funds for fiscal year 2021 as follows:
